The Member States of the Caribbean Community,

**RECOGNISING** that Article 36(1) of the Protocol on Public Procurement provides that a Member State may, upon the signing of this Protocol or at any later date before it enters into force, declare its intention to apply it provisionally;


**ALSO RECOGNISING** that pursuant to Article 36(2) upon a declaration by five (5) Member States, the provisions of the Protocol on Public Procurement shall be applied provisionally pending its entry into force in accordance with Article 38;

**HEREBY DECLARE** that they will provisionally apply the Protocol on Public Procurement.

**IN WITNESS WHEREOF**, the undersigned, being duly authorised by their respective Governments, have signed this Declaration.
